

# Call for Expression of Interest (EoI) for Consultant Roster 2024 to 2026

- Facilitating workshops, training sessions, and capacity-building activities

- Supporting monitoring and evaluation processes, including data analysis and impact assessment

## MINIMUM REQUIRED QUALIFICATIONS AND EXPERIENCE

At minimum a Bachelor's degree in a relevant field related to ICIMOD's areas of work. Candidates with a Master's degree or PhD are highly preferred.

Proven experience in the relevant area of expertise, preferably with a minimum of five years in a related field.

Proficiency in English; additional language skills relevant to the HKH region are an advantage.

### **APPLICATION PROCEDURE**

Interested individuals are invited to submit their expressions of interest through the <u>online application form</u> available on ICIMOD's website. We will accept and review applications on an ongoing basis. Applicants should provide detailed information on their qualifications, experience, and area of expertise.

Eligible consultants will be included in ICIMOD's roster for the period of 2024 to 2026 and may be contacted for submission of detailed technical and financial proposals as per ICIMOD's requirements. The roster will be updated regularly at ICIMOD's discretion.

ICIMOD's consultant selection process is based on the qualifications and competence of the applicants. As an employer, ICIMOD is committed to promoting diversity, equity, and inclusion, and offers equal opportunities to applicants from all backgrounds and walks of life, including but not limited to gender, age, national origin, religion, race, caste, ethnicity, sexual orientation, disability, or social status.
